From the Superintendent's Desk

Are your bags all packed? Are you ready to go? If so, you're a little early for the next Mid Central Region Convention. Usually, this month would bring us a 3-day convention where we'd be able to attend clinics, participate in modeling contests, visit layouts, and visit with other model railroaders from

the region. Not happening this year. But next year, just a two-hour drive north on I-65. . .

Next year is Indy Junction 2022, scheduled for May 18-22, 2022, in Indianapolis. If you're thinking that's not part of the Mid Central Region, you are absolutely correct. This will be a three-region event, with the Midwest Region, the North Central Region, and our own Mid Central

Region. That means three times the number of clinicians to draw from for some great clinics. Ron Ellison and I are working publicity. Bruce DeMaeyer, assisted by Bob Frankrone and Barbara Soward, is in charge of registration. The rest is covered by people from all three regions.

The convention will be in the Indianapolis Marriott East. This location is away from downtown with reasonable room rates, easy access from I-465/I-70, and FREE parking. The convention will be a day longer than usual to get in all the content we expect to have available. With the lower room rate, it's going to be a LOT less expensive for you to attend this convention than an entire week in a downtown venue, it will be at a much better time to be out and about than in the middle of the summer, and it's just a two-hour drive from L'ville.

Layout tours will be during the day – and they're ALL self-driving so you can spend as much time as YOU want at each stop. We are planning a two-day train show for Saturday and Sunday. But it won't be a flea market/buy/trade/sell type of event. You also will not see big name manufacturers who will only bring displays to the show. Instead, we're looking at having smaller but well-known manufacturers who will sell direct to you as an attendee.

We're planning all the rest of the usual things – contests, non-rail, prototype tours, and other activities. We are working on a couple other items, but because they're not yet confirmed, we are not quite ready to share those with you.

One other thing – the RPM Conference (Railroad Prototype Modelers) group has agreed to join us in this venture. So, not only will you have the things you'd expect at this convention, you'll also be able to attend clinics by some of the best modelers you'll see anywhere. They're also bringing display models for you to marvel at. All at no additional cost to you as an attendee.

Four Full Days, Three Regions, Two-Day Train Show, One Convention. What a deal!

APRIL CHARLIE KEELING MODEL CONTEST Photos submitted by the modelers



Above. Paul Downs took first place with his N Scale L&N "Kentucky Club". A model of a heavy weight passenger car that the L&N Railroad updated to match their newer steamlined and smooth side cars. The L&N removed only the window section for this car and added new, large windows of the same size and shape as the new streamliners. Paul took an existing coach, removed the sides, and then scratchbuilt new sides, cutting out each window. Because this car kept its sides below the belt rail, He added rivet details to depict its heavyweight heritage. He also added undercarriage and roof details, including a roof antenna.

The model was painted, decaled, and weathered. The decals (except for the stripes) were designed by Paul and printed by the old Rail Graphics company.

Right. Steve Lasher took second with this HO New York Central Observation Car. Steve began with a Walthers heavyweight observation car. He added interior lighting and Marker Lights. A safety bar down the aisle side, window shades, and figures were added, and the car was lightly weathered. The model belongs to Russ Weis.





Left. Bob Frankrone captured third place with his HO Catskill Mountain Scenic Railroad car.

The Catskill Mountain RR uses converted flat cars to transport passengers on a scenic ride through the Catskill Mountains. Bob modeled this passenger car to resemble the one he rode on in the summer of 2013. The sides and benches are scratch-built using scale lumber. The door to the seating area lifts in and out and is anchored in the car's stake pocket. Bob printed the signs on his computer. (more contest photos on page 6)



N-SCALE CHOPPED-NOSE RS3M

9951 was PC / Conrail's lone chop-nosed
RS3m. The cab windows, headlight/number
board assembly, and EMD exhaust stacks are
MP15 parts. The 36" EMD fans are resin, cast
from a mold made using fans from a GP9.
The remaining details are made from
styrene, photo-etched, and wire parts.
Penn Central rebuilt their aging fleet of Alco
RS3's using EMD prime movers and 36" fans
salvaged from scrapped E-units. The program
was continued by Conrail post-merger.
Aficionados will recognize the EMD exhaust
stacks and EMD 36" fans on the model.

DIFFERENT OCCUPATIONS, SIMILAR STORIES

Through many of my recent writings you may guess that Steve Lasher is a regular visitor to our house as is Stan White.

Once a week we get together for lunch, then work on my layout. During lunch we cover a number of subjects and, no surprise, railroading of some sort comes up. Often Stan or I will ask Steve a "what would happen if" question, but would you believe that Mr. railroad engineer Steve Lasher will ask Stan or me an aviation question?

So, over our many lunches we all came to learn there were many similarities in the aviation and railroading industries.

For starters, do you know that the pilot unions at air carriers such as United, Delta, UPS, and Fed Ex all fall under the National **Railway**

Labor Act? That's right, airline unions follow the rules of the 1926 federal railway laws which mostly deal with when a union can go on strike. You say I can't be serious - but I am. Google it for more information.

Rest, or lack of it, is another similarity. When I started with UPS I was, of course, at the bottom of the pilot seniority list and on a 24 hour reserve call out. With railroad freight crews both now and then, they, too, are on a 24 hour call out. Steve and I both said we'd call the schedulers and ask what number we were on the list and would start guessing should we get in a nap now and chance being awake all night waiting for that call. Or go to bed like "normal" people and hope the call didn't come through an hour after we turn off the light. We both said on a number of occasions we guessed wrong and boy, was it a long night!

Engineers and pilots have to walk around their respective machinery to see if the maintenance guys didn't miss anything. It was always a pleasure with our respective "walk-around" when it was pouring down rain or 10 below and snowing like heck.

Both Stan and I were made aware of our payload so we knew if our aircraft would get off the ground, and Steve his tonnage so he knew how to handle his mile long train.

Steve tells the story on a cold winter's night how snow was blowing in the cab through the door seal and how they would fix that problem with two-inch masking tape. He goes on to say the masking tape worked the best as duct tape was too sticky and hard to get off at the end of the trip. Steve says the masking tape was a standard carry item with all the seasoned engineers.


For me it wasn't snow, but rain. My DC-8, like all of them, had a side window that opened. Over the many years of service that window didn't seal tightly on the ground so when a heavy rain came water would trickle down right into our flight kit with all our charts and books. Always on those nights it wasn't masking tape we were looking for, but made sure we had plenty of paper towels on board to stuff around the window.
