POSING FIGURES

I'm using the above photo to make my point this month. It's from Russell Weis's famous "iPad" which has proven to be the equal of a good 35mm camera and more versatile because photos can be edited while still on the iPad. All the photos that Russ has done that have appeared in publications have been done with the trusty pad.

Specifically, though, I'd like to talk about the figures and how they're posed. First of all, if you want figures in a top-quality photo, stick to Preiser. They're the best in terms of detail and painting. The figures in the above photos will speak for themselves in that regard.

As for posing I remember an article I read years ago in Model Railroader about making your own figures (I ain't tryin' it. Although, 3D printing might make it more likely). The author talked about posing figures in terms of a) implied motion vs. b) frozen motion. The above photo illustrates this perfectly. Let's compare the four figures.

First, the porter is posing for a photo. Our brains expect him to be motionless because we know that's what you do to be photographed. Great "implied motion".

Second, the photographer. Here again, we expect a photographer to be still.

Third, the conductor is obviously standing motionless in a conversation. No problem with our brain's expectations there.

But now we come to the ringer! A classic illustration of "frozen motion". The brakeman at the right has his hand in the air. Our brains are confused and having trouble reconciling what it's seeing. Is his hand going up, down, out or back? What our brain has trouble reconciling it labels as "not real". The brakeman with his hand up was the first thing my wife, Bonnie, spotted that she said told her it was a model and not real.

So, for maximum realism, try to use figures that are posed in "implied motion" and limit or avoid posing figures in "frozen motion".

Finally, I'd like to make the case for the fun of photography. As has been said by many before me, it's a great way to improve your modeling. It's merciless when it comes to showing you the good and bad of your work. If it looks good to the camera it probably looks good in person. Perhaps we can get Russell to share some of his ideas about iPad photography in a future article. The fun comes when you do have to look at a photograph closely to tell it's a model!


Ham, or Smoked Turkey, all on a baguette with chips and a cookie.
