The Strange Case of James Hansen

We recognized James as a new member at our August 20, 2022 meeting. He was listed in the September 2022 *The Pie Card* as a renewal. That was incorrect, it was an address change, but a change was at least noted.

On August 1, 2022, I emailed him a welcome letter with full details about Division 8 including a link to the upcoming Gathering. The same day, he was invited to join Groups.io. and we added James to our email list. We did all the things we are supposed to do to welcome a new member to our division.

We continued to send James all Division 8 communications which included the monthly newsletter, the contest ballot, information about our Christmas Party in December. He received it all. But we never had any contact back from James Hansen until this when we sent him the February 2023 *The Pie Card*,

Charlie Buccola's HO L&N HK tower.

Charlie's model is constructed using Evergreen plastic siding materials, standing seam roofing, strips and shapes. Modified Grant Line windows were used to get the appropriate casing combinations, etc. Grant Line doors were used. Charlie built his model from plans he developed by scaling from photos and used references to L&N standard structure designs He custom mixed paint to obtain the grayed green used by L&N on their structures.



FIRST PLACE

Al Goodman's St.Jakobus Cathedral and Cemetery.

Al began with an HO Kibri cathedral kit . Roof, walls, stonework and downspouts were painted and weathered. LED strip lights were added for the interior lighting. Additional stained glass windows were printed from pictures on decal paper and added to windows included in the kit. He modified an existing church model to serve as the cemetery chapel and finished the scene with a funeral in progress.

Ed Brennan's S. MacDonald and Son Clock Works.

Ed began with an HO Northeastern basswood model of a mill that he bought several years ago. He liked the model, but he didn't need a mill, so it sat on his workbench for years. Recently he decided to move it to the front of the workbench. He changed it from a mill to a clock works, adding new details, glazed the windows, and created new roofing for the overhangs. He added additional details, figures, ands signs. He then weathered it and added weeds and underbrush around the foundation.

For our basement layout, we hosted two small operating sessions in the past month. We are now at the point that I feel comfortable hosting full operating sessions of up to three hours. There are four local switching jobs (two include some small industrial yard switching) and a three-train mainline meet. I could fill it out to five locals, but that would be pushing it a bit. All the concepts I wanted to implement for operating sessions and for the trackwork have been successfully tested. We need to tweak a couple things, but with the Touch Toggles now in place to move the mainline turnouts, we're pretty much complete with that stage of construction in the first two phases. Bob Dawson and Darcy Elliott joined me on that trip. I'm not entirely sure Darcy knew exactly what he was getting into, but he did say he's up for a return trip.



NOTICE OF VOTE ON PROPOSED CHANGES TO DIVISION 8 BYLAWS

The Board of Directors has proposed some minor changes to the bylaws.

We will vote to change the bylaws at the Division 8
Membership Meeting April 15, 2023. Here is a short summary of the changes.

Article 7, Section 6

A change to audit of the Treasurer's records on even numbered years in July rather than every year in July. Or within 60 days of a new Treasurer taking office if the change occurs out of the regular election cycle. The board recommends the change because an annual audit is excessive based on the volume of transactions that occur.

Article 7, Section 7

The current bylaws state that the Contest Committee conducts a contest at each general meeting. Since the contest is now conducted virtually, the wording is changed to reflect that.

Syntax changes to the entire bylaws to change "general meeting" to "membership meeting" in all instances. Other minor editorial and typographical corrections that are being made to make our bylaws grammatically correct.
